ORDINANCE NO. 8122

AN ORDINANCE PROVIDING BAIL BOND ASSISTANCE TO ALL BARANGAY OFFICIALS IN THE CITY OF MANILA WHO MAY HAVE BEEN ACCUSED FOR AN OFFENSE IN RELATION TO THE PERFORMANCE OF THEIR OFFICIAL DUTIES AND APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (Php 1,000,000.00) THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Bail bond assistance shall hereby be provided to all barangay officials in the City of Manila who may have been charged or accused or suspected of any offense in relation to the performance of their official duties.

SEC. 2. The coverage of this Ordinance shall include the following:

- 2.1 Barangay Chairman
- 2.2 Barangay Kagawad
- 2.3 Barangay Secretary
- 2.4 Barangay Treasurer
- 2.5 Chairman of the Lupon
- 2.6 Barangay Tanods
- SEC. 3. The guidelines for the implementation of this Ordinance shall be prepared by the City Legal Office and the Office of the City Mayor.
- SEC. 4. The amount of One Million Pesos (PhP 1,000,000.00) or so much thereof as may be necessary shall hereby be appropriated out of any unappropriated funds, existing in the City Treasury to be made available for the implementation of this Ordinance.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.
