

AN ORDINANCE RENAMING UNION STREET IN THE FIFTH DISTRICT OF MANILA TO F.M. GERNALE STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Union Street in the Fifth District of Manila is hereby renamed F.M. Gernale Street.

SEC. 2. The City Engineer is hereby directed to cause the replacement of the present street signs installed at strategic places thereat as follows:

F. M. GERNALE STREET  
(formerly Union Street)




SEC. 4. Effectivity Clause - This Ordinance shall take effect upon its approval.

Enacted by the City Council of Manila at its regular session today, August 29, 2006.




