

ORDINANCE NO. 8126

AN ORDINANCE RENAMING HOSPITAL STREET IN THE FIFTH DISTRICT OF MANILA JUSTICE CECILIA MUÑOZ PALMA STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Hospital Street in the Fifth District of Manila is hereby renamed Justice Cecilia Muñoz Palma Street.

SEC. 2. The City Engineer is hereby directed to replace or cause the replacement of the present street signs installed at strategic places thereat, from Arroceros Street up to Taft Avenue Ermita, Manila, as follows:

JUSTICE CECILIA MUÑOZ PALMA ST.
(formerly Hospital St.)

SEC. 3. Copies of this Ordinance be furnished the Office of the President, the Office of the Representative of the Fifth District of Manila, the Office of the Senate, the National Historical Institute, the Philippine Postal Corporation and the City Engineer's Office.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.
