

ORDINANCE NO. 8127

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED SEVENTY SIX MILLION ONE HUNDRED NINE THOUSAND FOUR HUNDRED SEVENTY FOUR PESOS (PHP 176,109,474.00) OUT OF THE GENERAL FUND SOURCED FROM DOMESTIC BORROWINGS, DULY CERTIFIED AS AVAILABLE FOR APPROPRIATION BY THE CITY TREASURER, AS CY 2006 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1, TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATION FOR THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS UNDER CY 2006 EXECUTIVE BUDGET ORDINANCE NO. 8111.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The amount of ONE HUNDRED SEVENTY SIX MILLION ONE HUNDRED NINE THOUSAND FOUR HUNDRED SEVENTY FOUR PESOS (PhP 176,109,474.00) is hereby appropriated out of the General Fund sourced from domestic borrowings, duly certified as available for appropriation by the City Treasurer in Local Budget Preparation Form No. 162-a and which budget document is hereto attached as Annex "A" and made an integral part hereof as CY 2006 General Fund Supplemental Budget No. 1, to be made available as additional appropriation for the Department of Engineering and Public Works under CY 2006 Executive Budget Ordinance No. 8111.

The funds herein appropriated shall be utilized for the object of expenditure as follows:




