

ORDINANCE NO. 8132

AN ORDINANCE WITHDRAWING FROM PUBLIC USE A PORTION OF FIRMEZA STREET CORNER T. ANZURES, SAMPALOC, MANILA, AND WITHIN THE JURISDICTION OF BARANGAY 553, ZONE 54, DISTRICT IV, MANILA AND CONVERTING THE SAME INTO PATRIMONIAL PROPERTY TO BE GIVEN TO ACTUAL AND BONA FIDE MEMBERS OF THE SAMAHANG MAGKAKAPITBAHAY NG FIRMEZA AT T. ANZURES (SAMAFITA).

Be it ordained by the City Council of Manila, THAT:


SECTION 1. The City road located at Firmeza Street corner T. Anzures St. Sampaloc, Manila and within the jurisdiction of Barangay 553, Zone 54, District IV, Manila, is hereby withdrawn from public use as a street and re-classified as patrimonial property whereon a medium-rise condominium shall be constructed to be allocated and awarded thru sale to bona fide members of the Samahang Magkakapitbahay ng Firmeza at T. Anzures (SAMAFITA).


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.


