

ORDINANCE NO. 8135

AN ORDINANCE FURTHER AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (TRICYCLE TERMINALS) AS AMENDED BY DELETING THE STA. ANA, PLAZA HUGO, MAKATI TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SAPHMTODA) UNDER NO. 7 THEREOF AND PLACING THEREIN THE STA. ANA, ISABEL CALDERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SAICTODA), AND SECTION 2, NO. 27 OF ORDINANCE NO 7871 AS AMENDED, BY DELETING SAPHMTODA AND PLACING THEREIN SAICTODA AND PROVIDING FOR ITS ALLOCATED NUMBER OF ONE (100) HUNDRED TRICYCLE UNITS.

PREAMBLE

WHEREAS, on July 30 1991, the City Council of Manila enacted Ordinance No. 7755 designating certain portions of the streets as pay loading and unloading areas for specific public utility vehicles including tricycles-for-hire;

WHEREAS, included in the list under Section 2.a., No. 7 thereof on Tricycle Terminals is the STA. ANA, PLAZA HUGO, MAKATI TRICYCLE OPERATORS AND DRIVERS ASSOCIATION OR SAPHMTODA;

WHEREAS, on 29 September 2003, the Certificate of Corporate Registration of SAPHMTODA in the Securities and Exchange Commission (SEC) was revoked pursuant to P.D. 902-A as amended, and as a consequence thereof, the association lost its legal personality to operate;

WHEREAS, with the revocation, the Executive Officers and Board of Directors and members of the STA. ANA, ISABEL CALDERON TRICYCLE OPERATORS and DRIVERS ASSOCIATION or SAICTODA opted to change the name of the SAPHMTODA to SAICTODA, with the latter having been duly registered in the SEC under Sec. Reg. No. 2002575548, both groups have routes;

WHEREAS, finally, on 29 February 2004, SAICTODA passed Board Resolution No. 16, stating that the Board of Directors and members approved to elevate to the SEC the matter for the dissolution of SAPHMTODA pursuant to P.D. No. 902-A and under Sec. 121 of the Corporate Code;

WHEREAS, thus, this proposal is submitted for the amendment of Ordinance No. 7755 by way of deletion of SAPHMTODA and placing there in the name of SAICTODA: NOW, THEREFORE,

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 2.a. of Ordinance No. 7755 (Tricycle Terminals), under No. 7 thereof is hereby further amended by deleting STA. ANA, PLAZA HUGO, MAKATI TRICYCLE OPERATORS AND DRIVERS ASSOCIATION and placing therein the STA. ANA, ISABEL CALDERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SAICTODA), to read as follows:

"7. STA. ANA-ISABEL CALDERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SAICTODA)."

Any succeeding amendment hereto as to its name shall be put to a moratorium and shall be done only within a period of ten (10) years



SEC. 2. Section 2, No. 27 of Ordinance No. 7871, is hereby further amended by deleting SAPHMTODA and placing therein SAICTODA, to read as follows:


ASSOCIATION	ROUTE	R.M.C.
"27. SAICTODA	Sta. Ana-Isabel- Calderon- Suter Streets	100 Units"


SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.


