

AN ORDINANCE AMENDING SECTION 2.a OF ORDINANCE 7755 TRICYCLE TERMINALS, AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF THE SM-SAN LAZARO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (SM-SLTODA) AND SECTION 2 OF ORDINANCE 7871, AS AMENDED, BY INCLUDING A ROUTE MEASURE CAPACITY.

Be it ordained, by the City Council of Manila, THAT:

SEC. 2. Section 2 of Ordinance No. 7871, is hereby amended by adding another number to be read as follows:




SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon approval.




