

AN ORDINANCE AUTHORIZING THE GABBY'S MUNTING PALENGKE INC., TO OPERATE A PRIVATELY OWNED TALIPAPA (FLEA MARKET) AT THE CORNER OF NEW PANADEROS EXTENSION AND AGLIPAY STREET, STA. ANA, MANILA, UNDER CERTAIN TERMS AND CONDITIONS.

Be it ordained by the City Council of Manila:

SECTION 1. The GABBY'S MUNTING PALENGKE, INC., is hereby authorized to operate a privately owned TALIPAPA (Flea Market) at the corner of New Panaderos Extension and Aglipay Street, Sta. Ana, Manila, subject to the following terms and conditions.

A. The City shall continue to have and exercise the power to impose all applicable permits, license fees and other service charges upon the franchisee and the stallholders thereat, in accordance with existing ordinances, rules and regulations.

B. The City shall, likewise, exercise the power granted by law to regulate, inspect and supervise the operation of the flea market to assure compliance with pertinent rules and regulations.

C. The grantee shall see to it that the administration of the privately owned TALIPAPA is done in the most efficient manner, in faithful compliance with the terms and conditions of this grant.

D. In the award of stalls, preferential rights shall be accorded to qualified Filipino citizens.

E. The operational expenses for the said privately owned TALIPAPA, including the maintenance, cleanliness and sanitation thereof shall be borne by the grantee.


SEC. 2. Any violation or breach by the grantee of the terms and/or conditions set forth herein shall be sufficient ground for the outright cancellation of the authority, revocation of the permit issued and closure of the TALIPAPA premises.


SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.
