ORDINANCE NO. 8145

AN ORDINANCE GRANTING A LIFETIME OLD AGE SUSTENANCE ASSISTANCE IN THE AMOUNT OF TWO THOUSAND PESOS (PHP 2,000.00) MONTHLY TO SURVIVING RETIRED MEMBERS OF THE DEFUNCT MANILA POLICE DEPARTMENT, UPON REACHING THE AGE OF 60, APPROPRIATING THE AMOUNT OF TWENTY MILLION PESOS (PHP 20,000,000.00), THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy - It shall hereby be declared the policy of the City Government of Manila to give tribute to retired members of the now defunct Manila Police Department (MPD) who have achieved honorable distinction as "Manila's Finest" (eventually became "Asia's Best") and for dedication to duty as police officers.

- SEC. 2. Pursuant to this policy, an Old Age Sustenance Assistance for the surviving retired members of the defunct MPD is hereby created. It shall be known as the OASA, for brevity.
- SEC. 3. The OASA shall be in the amount of Two Thousand Pesos (PhP 2,000.00) and shall be given to the following:
 - a. Retired MPD Officers who have reached the age of 60;
 - Those who have received their original appointments from the City of Manila as Patrolman/Detective or its equivalent; and
 - c. Must have served in the MPD for at least fifteen (15) years at the time of retirement or separation from the service.
- SEC. 4. The amount of Twenty Million Pesos (PhP 20,000,000.00) or so much thereof, as may be necessary, shall hereby be appropriated out of any unappropriated funds existing in the City Treasury to be made available for the effective implementation of this Ordinance.
 - SEC. 5. This Ordinance shall take effect upon its approval.
