

ORDINANCE NO. 8151

AN ORDINANCE FURTHER AMENDING SECTION 2.a OF ORDINANCE NO. 7755, AS AMENDED. BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF MCU-MONUMENTO-DIVISORIA TRANSPORT DRIVERS, OPERATORS ASSOCIATION, INC. (MMODITRANS).

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 2.a of Ordinance No. 7755, is hereby further amended by adding another number to be read as follows:

30. "MCU-MONUMENTO-DIVISORIA TRANSPORT DRIVERS, OPERATORS ASSOCIATION, INC. (MMODITRANS)"

a. Antonio Rivera Street near the corner of C.M. Recto Avenue


SEC. 2. Effectivity Clause – This Ordinance shall take effect upon its approval.


