

ORDINANCE NO. 8154

AN ORDINANCE CREATING THE POSITIONS OF SEVENTY-FIVE (75) DAYCARE CENTER WORKER I IN THE MANILA DEPARTMENT OF SOCIAL WELFARE, APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. CREATION. - There is hereby created a position of seventy-five (75) Daycare Center Worker I under the Manila Department of Social Welfare.

SEC. 2. RESPONSIBILITIES. - The Daycare Center Worker I shall have the following duties and responsibilities:

- a. Enhance the physical, social, emotional, cognitive, psychological, spiritual and language development of young children;
- b. Help enhance the role of parents and other caregivers as the primary caregivers and educators of their children from birth onwards;
- c. Facilitate a smooth transition from care and education provided at home to the community or school-based setting and to the primary school;
- d. Ensure that young children are adequately prepared for the formal learning system and that both public and private schools are responsive to the developmental needs of these children;
- e. Help establish an efficient system for early identification, prevention, referral and intervention for developmental disorders and disabilities in early childhood;
- f. Implement programs that improve infant and child survival rates by ensuring that adequate health and nutrition programs are accessible to young children and their mothers.

SEC. 3. SALARY. - A Daycare Center Worker shall receive a monthly compensation of FIVE THOUSAND FIVE HUNDRED NINETY PESOS (PhP 5,590.00) or equivalent to a Salary Grade 1-1 including all other benefits due to any regular employee of the City of Manila.

SEC. 4. PRIORITIZATION. - A Daycare Center Worker who has served the City of Manila as volunteer for fifteen (15) years or more shall be given first priority in the implementation of this Ordinance.

SEC. 5. APPROPRIATION. - The amount of EIGHT MILLION PESOS (PhP 8,000,000.00), or so much thereof as may be necessary, shall hereby be appropriated out of any unappropriated funds existing in the City Treasury for the implementation of this Ordinance.




SEC. 7. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon its approval.


