

ORDINANCE NO. 8155

AN ORDINANCE AMENDING SECTIONS 1 & 2 OF CITY ORDINANCE NO. 8089, BY PLACING THEREIN METROBANK AS REGISTERED OWNER IN LIEU OF CESAR B. PAPA, TCT NO. 264249 IN LIEU OF TCT NO. 155271, IN SECTION 1 THEREOF, AND SPECIFYING FRANCO PITONG GATANG ZAMORA NEIGHBORHOOD TENANTS ASSOCIATION, INC. AS QUALIFIED BENEFICIARIES IN SECTION 2 THEREOF.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Sections 1 and 2 of Ordinance No. 8089 are hereby amended to appear as follows:

"Section 1. The Honorable City Mayor of Manila shall hereby be authorized to work for the acquisition, either by negotiation or expropriation, parcels of land situated at Calle Pitong Gatang, Nicolas Zamora and Franco Street, Tondo, Manila, owned by hereunder listed registered owners and covered by corresponding Transfer Certificate of Title Nos., to wit:

Sec. 2. The aforementioned parcels of land shall upon acquisition, be resold at cost on installment basis to bona fide members of **Franco Pitong Gatang Zamora Neighborhood Tenants Association, Inc..**"


SEC. 2. This Ordinance shall take effect upon its approval.


