

ORDINANCE NO. 8158

AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHTY NINE MILLION NINE HUNDRED TWENTY THOUSAND FOUR HUNDRED FORTY PESOS (PHP 89,920,440.00) TO COVER THE STATUTORY OBLIGATIONS OF THE CITY OF MANILA TO ITS PUBLIC HEALTH WORKERS (MANILA PUBLIC HEALTH EMPLOYEES AND HOSPITAL WORKERS), BY WAY OF A SUPPLEMENTAL BUDGET TO APPROPRIATION ORDINANCE NO. 8131.

Be it ordained by the City Council of Manila, duly assembled, THAT:

SECTION 1. The amount of Eighty Nine Million Nine Hundred Twenty Thousand Four Hundred Forty Pesos (Php 89,920,440.00) is hereby appropriated by way of a Supplemental Budget to cover the Contractual and Statutory Obligations of the City of Manila to its public health workers as of September 2006 Budget, subject to final computation.

SEC. 2. The appropriated amount shall be broken down as follows:


SEC. 4. Effectivity Clause – This Ordinance shall take effect immediately upon its approval.


