

ORDINANCE NO. 8160

AN ORDINANCE WITHDRAWING FROM PUBLIC USE THAT CERTAIN PARCEL OF LAND WITH AN AREA OF FORTY SQUARE METERS (40 SQ. M.), MORE OR LESS, WHICH IS THE SITE OF AN ALLEY BETWEEN JACINTO STREET AND SAMPAGUITA STREET, PANDACAN, IN THE 6TH DISTRICT OF MANILA, CONVERTING THE SAME AS PATRIMONIAL PROPERTY OF THE CITY, FOR USE EXCLUSIVELY AS SITE OF THE BARANGAY HALL/DAY CARE CENTER OF BARANGAY 845, ZONE 92.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. That certain parcel of land with an area of FORTY SQUARE METERS (40 Sq. M.), more or less, which is the site of an alley between Jacinto Street and Sampaguita Street, Pandacan, in the 6th District of Manila and registered under the name of the City of Manila, is hereby withdrawn from public use and converted as patrimonial property of the City, for use exclusively as site of the Barangay Hall/Day Care of Barangay 845, Zone 92.


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.


