

AN ORDINANCE RE-OPENING THE ROAD END OF F. MUÑOZ STREET TOGETHER WITH THE CORRESPONDING EASEMENT ROW LOCATED AT BARANGAY 735, ZONE 80, FIFTH DISTRICT OF MANILA, THEREBY CREATING A PEDESTRIAN AND VEHICULAR ACCESS TO PRESIDENT SERGIO OSMEÑA HIGHWAY, CITY OF MANILA.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. The road end of F. Muñoz St., together with the corresponding easement row located at Barangay 735, Zone 80 in the Fifth District is hereby re-opened in order to create a pedestrian and vehicular access to President Sergio Osmeña Highway, City of Manila.


SEC. 2. The City Engineer's Office and other concerned agencies are hereby mandated to clear said areas and effect Section 1, hereof.


SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

Enacted by the City Council of Manila at its regular session held today, July 1, 2008.




