

ORDINANCE NO. 8165

AN ORDINANCE CREATING THE POSITIONS OF FIFTY (50) BARANGAY HEALTH WORKER I UNDER THE MANILA HEALTH DEPARTMENT, APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1. CREATION.** - There is hereby created a position of fifty (50) Barangay Health Worker I under the Manila Health Department.

**SEC. 2. RESPONSIBILITIES.** - The Barangay Health Worker I shall have the following duties and responsibilities:

- a. Render primarily health care services such as, but not limited to, giving of immunization, regular weighing of children, implementation of local health programs in the barangay after having been accredited to function as such by the Manila Local Health Board in accordance with the guidelines promulgated by the Department of Health and shall undergo training programs under any accredited government and non-government organization;
- b. Provide information, education and motivation services for primary health care, maternal and child health, child rights, family planning and nutrition to the barangays.

**SEC. 3. SALARY.** - A Barangay Health Worker I shall receive a monthly compensation of FIVE THOUSAND FIVE HUNDRED NINETY PESOS (PhP 5,590.00) or equivalent to a Salary Grade 1-1 plus all the other benefits due to any regular employee of the City of Manila.

**SEC. 4. PRIORITIZATION.** - A Barangay Health Worker who has served the City of Manila as volunteer for fifteen (15) years or more shall be given first priority in the implementation of this Ordinance.

**SEC. 5. APPROPRIATION.** - The amount of FIVE MILLION FIVE HUNDRED THOUSAND PESOS (PhP 5,500,000.00), or so much amount thereof as may be necessary, shall hereby be appropriated out of any unappropriated funds existing in the City Treasury for the implementation of this Ordinance.

**SEC. 6.** Copies of this Ordinance shall be furnished the Office of the Mayor, the Manila Health Department, the Office of the City Personnel and the City Treasurer of Manila.


**SEC. 7. Effectivity Clause.** - This Ordinance shall take effect upon its approval.


