

ORDINANCE NO. 8172

AN ORDINANCE PROVIDING ACCIDENT, HEALTH AND OTHER BENEFITS FOR ALL PUBLIC ELEMENTARY AND HIGH SCHOOL STUDENTS IN THE CITY OF MANILA BY REGISTERING THEM AS RED CROSS MEMBERS.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. PURPOSE. - The purpose of this Ordinance is to provide public elementary and high school students with accident, health and other benefits, and necessary training for accident and disaster preparedness.

SEC. 2. RED CROSS MEMBERSHIP. - All elementary and high school students in the City of Manila shall hereby be registered as classic Red Cross members on an annual basis which will entitle them to the following benefits:

- A. Accident and Health, Death, Disability and Dismemberment Coverage of PhP 12,000.00.
- B. Unprovoked Murder and Assault Coverage of PhP 12,000.00.
- C. Accident Medical Reimbursements of PhP 5,000.00.
- D. Burial Benefits of PhP 5,000.00.
- E. Daily Hospital Allowance (for a maximum of 60 days) of PhP 150.00 a day.

SEC. 3. TRAININGS. - All Grade IV elementary up to Fourth year high school students will undergo continuing First Aid and Disaster Management Training yearly.


SEC. 4. APPROPRIATION. - The amount of PhP 10,000,000.00, or so much thereof as may be necessary, is hereby appropriated, out of any unappropriated funds existing in the City Treasury or other financial institutions to be made available to cover the premiums necessary for Red Cross registration of all the public elementary and high school students in the City of Manila.


SEC. 5. Effectivity Clause. - This Ordinance shall take effect the following school year after its approval and every year thereafter.

Enacted by the City Council of Manila at its regular session held today, September 30, 2008.




