

ORDINANCE NO. 8176

AN ORDINANCE PROVIDING FOR AN INCREASE OF THE MONTHLY ALLOWANCES OF THE JUDGES, CLERKS OF COURT, ASSISTANT CLERKS OF COURT AND THE BRANCH CLERKS OF COURT OF THE REGIONAL TRIAL COURTS (RTC) AND METROPOLITAN TRIAL COURTS (MTC) OF THE CITY OF MANILA, AND PROVIDING FUNDS NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. The monthly allowances of the court officials in the City of Manila, listed below shall hereby be increased as follows:

1. Judges (RTC and MTC) from PhP 8,000.00 to PhP 12,000.00;
2. Clerk of Court (RTC) from PhP 8,000.00 to PhP 12,000.00;
3. Assistant Clerk of Court (RTC) from PhP 4,000.00 to PhP 6,000.00;
4. Clerk of Court (MTC) from PhP 8,000.00 to PhP 10,000.00;
5. Assistant Clerk of Court (MTC) will be given an additional allowance of PhP 2,500.00.
6. All Branch Clerks of Court of RTC or its equivalent rank (Salary Grade 24) and all Branch Clerks of Court of MTC will be given an additional allowance of PhP 2,500.00.

SEC. 2. Such amount, as maybe necessary, for the effective implementation of Section 1 hereof is hereby authorized to be appropriated in the Annual Executive Budget of the year following the enactment of this Ordinance.




SEC. 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.




