

ORDINANCE NO. 8180

AN ORDINANCE RENAMING CONDESA STREET, BINONDO, IN THE THIRD DISTRICT OF MANILA TO NORBERTO TY STREET.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1.** Condesa Street, Binondo, in the Third District of Manila from Yuchengco Street (Nieva St.) up to Plaza Lorenzo is hereby renamed Norberto Ty Street.

**SEC. 2.** The City Engineer is hereby directed to cause the replacement of the present street signs installed at strategic places thereat as follows:

NORBERTO TY STREET  
(formerly Condesa Street)


**SEC. 3.** Copies of this Ordinance be furnished the Office of the President, the Office of the Representative of the Third District of Manila, the National Historical Institute, the Philippine Postal Corporation and the City Engineer's Office.


**SEC. 4. Effectivity Clause.** - This Ordinance shall take effect upon its approval.


