

ORDINANCE NO. 8181

AN ORDINANCE RENAMING ORIENTE STREET, BINONDO, IN THE THIRD DISTRICT OF MANILA TO VICTORIA TY TAN STREET.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1.** Oriente Street, Binondo, in the Third District of Manila from Yuchengco Street (Nieva St.) up to Plaza Lorenzo is hereby renamed Victoria Ty Tan Street.

**SEC. 2.** The City Engineer is hereby directed to cause the replacement of the present street signs installed at strategic places thereat as follows:

VICTORIA TY TAN  
STREET  
(formerly Oriente Street)



Enacted by the City Council of Manila at its regular session held today, January 27, 2009.





