## ORDINANCE NO. <u>9189</u>

AN ORDINANCE RENAMING ESTRADA AND MABUHAY STREETS IN THE FIFTH DISTRICT OF MANILA TO SAGRADA PAMILYA STREET.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

- SECTION 1. Estrada Street and Mabuhay Street in the Fifth District of Manila from Osmefia Highway up to Tejeron Street are hereby renamed Sagrada Pamilya Street.
- SEC. 2. The City Engineer is hereby directed to cause the replacement of the present street signs installed at strategic places thereat as follows:

## SAGRADA PAMILYA STREET

(formerly Estrada-Mabuhay Street)

- SEC. 3. Copies of this Ordinance be furnished the Office of the President, the Office of the Representative of the Fifth District of Manila, the National Historical Institute (NHI), the Philippine Postal Corporation and the City Engineer's Office (CEO).
- SEC. 4. Repealing Clause. All Ordinances or portions thereof which are contrary to the provisions of this Ordinance or portion hereof are hereby deemed modified and repealed.
  - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.
