

ORDINANCE NO. 8190

AN ORDINANCE FURTHER AMENDING SECTION 1 OF ORDINANCE NO. 8136, AS AMENDED, BY INCLUDING THEREIN THE ADDITIONAL LOADING AND UNLOADING AREAS OF THE SM-SAN LAZARO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (SM-SLTODA).

- c. **Laguna Street near the corner of Rizal Avenue**


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.
