

ORDINANCE NO. 8197

AN ORDINANCE AMENDING SEC. 6 (e) OF ORDINANCE NO. 7961 BY SEPARATING THE MUSEO NG MAYNILA FROM THE MANILA TOURISM AND CULTURAL AFFAIRS BUREAU AND PLACING THE SAME UNDER THE OFFICE OF THE MAYOR.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1.** Section 6 (e) of Ordinance No. 7961 is hereby amended to read as follows:

**SECTION 6. CHANGE IN THE ORGANIZATION,  
ADMINISTRATIVE AND APPROPRIATED FUNDS  
IMPLEMENTATION:**

**“(e) The Museo ng Maynila (Museo) is hereby separated from the Manila Tourism and Cultural Affairs Bureau (MTCAB) and placed under the Office of the Mayor.**

**(e.1) The following list of existing positions under the Museo as indicated in the personnel schedule of Ordinance No. 8177 of FY 2009 shall constitute the personnel complement of the office, thus:**

**PROVIDED, That the remaining positions under the Museo after its segregation and as provided for in the same personnel schedule shall be retained in the MTCAB.**

**(e.2) The MTCAB and the Museo shall accordingly conduct an inventory within a period of 30 days from the approval of this Ordinance: PROVIDED, That thereafter, the property and equipment previously acquired prior to segregation shall be properly assigned and shall respectively belong to each of the separated offices.**


**(e.3) All funds due to the Museo shall be separated from that of the MTCAB and shall be deposited under the account allocated to the former."**


**SEC. 2.** This Ordinance shall take effect upon its approval.


