

AN ORDINANCE GRANTING THE BAMBANG MASANGKAY TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (BAMTODA) LOADING AND UNLOADING AREAS, AMENDING FOR THE PURPOSE SECTION 2.a OF ORDINANCE NO. 7755 (LOADING AND UNLOADING) AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN THE ROUTE MEASURE CAPACITY, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. Section 2.a of Ordinance No. 7755 (loading and unloading), is hereby further amended by including therein the Loading and Unloading Areas of Bambang Masangkay Tricycle Operators and Drivers Association, Inc. (BAMTODA), to read as follows:

- a. Bambang Street near the corner of Rizal Avenue
- b. Bambang Street near the corner of Andalucia Street
- c. Quiricada Street near the corner of Rizal Avenue
- d. Alvarez Street near the corner of Rizal Avenue

SEC. 2. Section 2 of Ordinance No. 7871 is hereby further amended by including therein the Route Measure Capacity and the Authorized Route Line, to read as follows:






