

AN ORDINANCE AUTHORIZING THE USE AND DEVELOPMENT OF A LOT OWNED BY THE CITY OF MANILA, MEASURING APPROXIMATELY ONE HUNDRED SIXTY EIGHT SQUARE METERS AND FIVE DECIMETERS (168.05 SQ. M.), PARTICULARLY DENOMINATED AS LOT NOS. 11 AND 40, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 10845, FOR THE BENEFIT OF BARANGAY 301, ZONE 29 IN THE 3<sup>RD</sup> DISTRICT OF MANILA, FOR THE CONSTRUCTION OF A MULTI-PURPOSE BARANGAY HALL AND DAY CARE CENTER FACILITY AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1. Declaration of Policy.** - It is hereby declared the policy of the City of Manila to enact Ordinances which shall ensure the efficient and effective delivery of basic services and facilities as provided under Sub-Paragraph (vi), Paragraph (b), Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

**SEC. 2.** Pursuant to this policy, the use and development of a portion of that vacant lot measuring approximately One Hundred Sixty-Eight Square Meters and Five Decimeters (168.05 sq.m.), particularly denominated as Lot Nos. 11 and 40, owned by the City of Manila and covered by Transfer Certificate of Title No. 10845, for the benefit of Barangay 301, Zone 29, District III, Manila, for the construction of a multi-purpose barangay hall and day care facility thereat, is hereby authorized.


**SEC. 3.** A Comprehensive Development Plan shall be submitted for prior approval of the Mayor before the implementation of this Ordinance: *PROVIDED*, That expenses for construction and development purposes shall be taken from the barangay budget and other sources from the private sector.


**SEC. 4. Effectivity Clause.** - This Ordinance shall take effect upon its approval.




