

ORDINANCE NO. 8207

AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NO. 8201 BY ADDING ONE HUNDRED SIXTY (160) ADDITIONAL REGULAR PLANTILLA POSITIONS.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1.** Section 5 of Ordinance No. 8201 is hereby amended to read as follows:

"Sec. 5. It shall have an organizational structure and staffing pattern composed of Four Hundred Twenty Two (422) regular plantilla positions and an additional One Hundred Sixty (160) regular plantilla positions, as follows:


**SEC. 2. Effectivity Clause.** - This Ordinance shall take effect upon its approval.






