AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR, TO ACQUIRE EITHER BY PURCHASE OR EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, THOSE CERTAIN PARCELS OF LAND, OWNED BY JULIE PUA ONG SITUATED IN LAKANDULA STREET AND FOLGUERAS STREET, TONDO, DISTRICT I, MANILA, AND COVERED BY TRANSFER CERTIFICATES OF TITLE (TCT) NOS. 240361, 240362 AND 240363 AND CONSISTING AN AREA OF SIX HUNDRED FIFTY ONE SQUARE METERS AND SEVENTY SQUARE DECIMETERS (651.70 SQ. M.), MORE OR LESS, FOR RE-SALE AT COST AND/OR INSTALLMENT BASIS NOT EXCEEDING TWENTY (20) YEARS TO THE MEMBER-BENEFICIARIES OF THE ZONE 1 LAKANDULA NEIGHBORHOOD ASSOCIATION, INC., APPROPRIATING THE AMOUNT NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. His Honor, the Mayor, is hereby authorized to acquire by purchase or expropriation or by any other legal means, those certain parcels of land owned by Julie Pua Ong situated in Lakandula Street and Folgueras Street, Tondo, District I, Manila, covered by Transfer Certificates of Title (TCT) Nos. 240361, 240362 and 240363 and consisting an area of Six Hundred Fifty One Square Meters and Seventy Square Decimeters (651.70 sq. m.), more or less, to wit:

- **SEC. 2.** The amount necessary to effectively carry out the provisions of this Ordinance shall be taken from the lump sum of the next annual executive budget following the approval of this Ordinance, *PROVIDED*, *That* it will be subject for inclusion to a specified amount for land acquisition purposes as well as the official confirmation that the same is available and may be appropriated as certified by the City Treasurer.
- **SEC. 3.** The aforementioned parcels of land, when acquired, shall be subdivided and resold at cost and/or on installment basis not exceeding twenty (20) years to the qualified member-beneficiaries of the *Zone 1 Lakandula Neighorhood Association*, *Inc.* 
  - SEC. 4. This Ordinance shall take effect upon its approval.
