AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO. 8089, AS AMENDED BY ORDINANCE NO. 8155, BY APPROPRIATING THE AMOUNT OF NINE MILLION SEVEN HUNDRED ELEVEN THOUSAND AND NINE PESOS (PHP 9,711,009.00), OR SO MUCH THEREOF AS MAY BE NECESSARY.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. Section 3 of City Ordinance No. 8089 as amended by Ordinance No. 8155, is hereby further amended to read as follows:

"Section 3. The amount of Nine Million Seven Hundred Eleven Thousand and Nine Pesos (PhP 9,711,009.00) is hereby appropriated out of the unappropriated funds available in the City Treasury to ensure that the provisions of this Ordinance are carried out in accordance with its goals and objectives."

SEC. 2. The amendment herein made automatically amends the title of City Ordinance No. 8089.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.
