

AN ORDINANCE GRANTING ALLOWANCES TO THE PERSONNEL OF THE DIVISION OF DENTAL SERVICES, UNDER THE MANILA HEALTH DEPARTMENT, AND APPROPRIATING THE AMOUNT NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. Grant of Allowances. - There is hereby granted allowances for personnel of the Division of Dental Services, under the Manila Health Department including those existing, but unoccupied items of the same positions, as of the date of enactment of this Ordinance.

SEC. 2. Allowances Schedule. - Those personnel occupying the positions as Dentists II, III, IV and V as per City of Manila Executive Budget, shall receive allowances in accordance with the following schedule, to wit:

SEC. 3. Appropriation Clause. - The amount, or so much thereof as may be necessary, shall hereby be appropriated out of any unappropriated funds existing in the City Treasury, to be made available, for the implementation of this Ordinance.


SEC. 4. This Ordinance shall automatically cease to be in force and effect upon the standardization in accordance with law of the salary grades of the above-mentioned positions.


SEC. 5. Effectivity Clause. - This Ordinance shall take effect upon its approval.




