

ORDINANCE NO. 8222

AN ORDINANCE AMENDING ORDINANCE NO. 7818 BY MODIFYING THE COVERAGE THEREOF AND HEREBY AUTHORIZING HIS HONOR, THE CITY MAYOR, TO EXPROPRIATE ONLY THE PARCELS OF LAND, COVERING AN APPROXIMATE AREA OF FOUR THOUSAND TWO HUNDRED FIFTY-ONE SQUARE METERS MORE OR LESS (4,251 SQ.M.), COVERED BY THE FOLLOWING TRANSFER CERTIFICATES OF TITLE (TCT) OR SPECIFIC PORTIONS THEREOF, NAMELY: PARAGRAPH 3 OF TCT NO. 228659 (LOT NO. 5 OF BLOCK 2995), TCT NOS. 228625, 228696, 228699, 228700, 228701, 228702, 228704, 228705, 228706, 228708, 228709, 228711, 228713, 228714, 228718, 228662, 228663, 228665, 228666, 228671, 228673, 228676, 228677, 228683, 228684, 228687, 228689; PARAGRAPH 9 OF TCT NO. 228659 (LOT NO. 5 OF BLOCK 2999), TCT NOS. 228721, 228724, 228725, 228726, 228727, 228728, 228729, 228733, 228736 AND 228737, ALL LOCATED IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the City Council of Manila, in session, assembled, THAT:


SECTION 1. Ordinance No. 7818 is hereby amended by modifying the coverage thereof and hereby authorizing His Honor, the City Mayor to expropriate only the parcels of land, covering an approximate area of Four Thousand Two Hundred Fifty-One Square Meters (4,251 Sq. M.) covered by the following Transfer Certificates of Title (TCT) or specific portions thereof, namely: Paragraph 3 of TCT No. 228659 (Lot No. 5 of Block 2995), TCT Nos. 228625, 228696, 228699, 228700, 228701, 228702, 228704, 228705, 228706, 228708, 228709, 228711, 228713, 228714, 228718, 228662, 228663, 228665, 228666, 228671, 228673, 228676, 228677, 228683, 228684, 228687, 228689; Paragraph 9 of TCT No. 228659 (Lot No. 5 of Block 2999), TCT Nos. 228721, 228724, 228725, 228726, 228727, 228728, 228729, 228733, 228736 and 228737, all located in the Third District of Manila.


SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.


