There is hereby appropriated from the General Fund sourced from the savings of salaries and wages of identified Regular Plantilla Positions in the City of Manila and reverted to the General Fund, duly certified by the City Treasurer as actually available, the sum of Forty-Three Million, Two Hundred Forty-Three Thousand, Eight Hundred and Eighty-Nine Pesos (PhP 43,243,889.00), as General Fund Supplemental Budget No. 1, and which budget documents marked as **Annex "A"** for Statement of Funding Sources (LBP Form No. 9), and **Annex "B"** for Statement of Supplemental Appropriation (LBP Form No. 10) are attached and made an integral part hereof, to be made available as additional appropriations of the City Government of Manila for Calendar Year 2010.
