

ORDINANCE NO. 8224

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 8222, BY MODIFYING ITS COVERAGE BY DELETING TRANSFER CERTIFICATE OF TITLE (TCT) NO. 228625 AND PARAGRAPH 3 OF TCT NO. 228659 (LOT NO. 5 OF 2995) AND INCLUDING TCT NO. 228660 (LOT NO. 2 OF BLOCK 2995) AND TCT NO. 228695 (LOT NO. 3-A OF BLOCK 2995).

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. Section 1 of the City Ordinance No. 8222 is hereby amended to read as follows:


"SEC. 1. Ordinance No. 7818 as amended by Ordinance No. 8222, is hereby further amended by modifying the coverage thereof and hereby authorizing His Honor, the City Mayor to expropriate only the parcels of land, covering an approximate area of Four Thousand Two Hundred Fifty-One Square Meters (4,251 Sq. M.) covered by the following Transfer Certificates of Title (TCT) or specific portions thereof, namely: TCT No. 228660 (Lot 2 of Block 2995), TCT Nos. 228695 (Lot 3-A of Block 2995), 228696, 228699, 228700, 228701, 228702, 228704, 228705, 228706, 228708, 228709, 228711, 228713, 228714, 228718, 228662, 228663, 228665, 228666, 228671, 228673, 228676, 228677, 228683, 228684, 228687, 228689; Paragraph 9 of TCT NO. 228659 (Lot No. 5 of Block 2999), TCT Nos. 228721, 228724, 228725, 228726, 228727, 228728, 228729, 228733, 228736 and 228737, all located in the Third District of Manila."


SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.




