

ORDINANCE NO. 8235

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS, OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF EIGHT HUNDRED NINETY-SIX SQUARE METERS (896 SQ. M.), MORE OR LESS, LOCATED AT PACO, MANILA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 211000, REGISTERED UNDER THE NAME OF OLIVER POSADAS, ET. AL.

Be it ordained by the City Council of Manila, in session, assembled, *THAT*:

SECTION 1. The City Mayor is hereby authorized to cause the acquisition, either by negotiation, expropriation or by any other legal means, of that certain parcel of land with an area of Eight Hundred Ninety-Six Square Meters (896 Sq. M.), more or less, located at Paco, Manila, covered by TCT No. 211000, registered under the name of Oliver Posadas, et. al.

SEC. 2. The aforementioned parcel of land, upon acquisition, shall henceforth be used as public road under the jurisdiction of the City of Manila.


SEC. 3. The amount of Thirteen Million Pesos (PhP 13,000,000.00) or so much thereof, as may be necessary is hereby appropriated, out of any unappropriated funds existing in the City Treasury, to be made available for the implementation of this Ordinance.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.
