

ORDINANCE NO. 0236

AN ORDINANCE FURTHER AMENDING SECTION 2.a. OF ORDINANCE NO. 7755 (TRICYCLE TERMINALS), AS AMENDED, BY EXTENDING THE ROUTE OF THE TAYABAS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (TATODA) FROM TAYABAS STREET CORNER RIZAL AVENUE TO FELIX HUERTAS STREET

Be it ordained by the City Council of Manila, in session, assembled, *THAT*:

SECTION 1. Section 2.a. of Ordinance No. 7755 (Tricycle Loading and Unloading Areas), as amended, is hereby further amended by extending the route of the Tayabas Tricycles Operators and Drivers Association (TATODA) from Tayabas Street corner Rizal Avenue up to Felix Huertas Street, to read as follows:

13. Tayabas Tricycle Operators and Drivers Association (TATODA)

a. Tayabas Street corner Rizal Avenue to Felix Huertas Street

SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.
