

ORDINANCE NO. 8241

AN ORDINANCE REGULATING THE USE OF THE CORNERS OF VERONICA STREET AND REINA REGENTE STREET, VICTORIA TYTANA STREET AND PLAZA LORENZO RUIZ, NORBERTO TY STREET AND PLAZA LORENZO RUIZ, TOMAS PINPIN STREET AND ONGPIN STREET AND ENRIQUE T. YUCHENGCO STREET AND ONGPIN STREET, ALL IN BARANGAY 288, ZONE 27, IN THE THIRD DISTRICT BY ALLOWING THE BARANGAY TO PUT UP GATES FROM 12:00 MIDNIGHT TO 5:00 IN THE MORNING TO BE MANNED BY BARANGAY OFFICIALS AND BARANGAY TANODS AND FOR OTHER PURPOSES

*Be it ordained by the City Council of Manila, in session, assembled, THAT:*

**SECTION 1.** *The corners of Veronica Street and Reina Regente Street, Victoria Tytana Street (formerly Oriente St.) and Plaza Lorenzo Ruiz (formerly Plaza Calderon dela Barca), Norberto Ty Street (formerly Condesa St.) and Plaza Lorenzo Ruiz, Tomas Pinpin Street and Ongpin Street and Enrique T. Yuchengco Street (formerly Nueva St.) and Ongpin Street, all in Barangay 288, Zone 27, in the Third District are hereby regulated by allowing the barangay to put up gates thereat to be manned by Barangay Officials and Barangay Tanods, from 12:00 midnight to 5:00 in the morning.*

**SEC. 2.** *To facilitate the passage of vehicles going to Ongpin Street, from Reina Regente Street, a traffic light shall be installed at the corner of Quintin Paredes and Ongpin Streets.*

**SEC. 3.** *The Manila Police District and the Manila Traffic and Parking Bureau are hereby directed to implement this Ordinance accordingly.*

**SEC. 4.** *The Manila District Traffic Enforcement Unit is hereby directed to install the appropriate signages along the streets so declared regulated.*

**SEC. 5. Penalty Clause.** *— Any person violating any of the provisions of this Ordinance shall be penalized by a fine of Three Hundred Pesos (PhP 300.00) and/or imprisonment of not more than six (6) months, or both, at the discretion of the Court.*

**SEC. 6. Repealing Clause.** *— All ordinances or parts thereof, which are inconsistent with this Ordinance are hereby repealed, amended or modified accordingly.*


**SEC. 7. Effectivity Clause.** *— This Ordinance shall take effect upon its approval.*
