

ORDINANCE NO. 8242

AN ORDINANCE WITHDRAWING FROM PUBLIC USE THAT CERTAIN PARCEL OF LAND SITUATED AT DAHLIA STREET IN LEVERIZA, MALATE, MANILA, BARANGAY 720, ZONE 78, IN THE FIFTH DISTRICT, RECLASSIFYING THE SAME FROM ROAD LOT TO LOT FOR THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA, PROVIDING FOR ITS USE, AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session, assembled, *THAT*:

SECTION 1. Dahlia Street in Leveriza, Malate, Manila, situated in Barangay 720, Zone 78, in the Fifth District is hereby withdrawn from public use as a road lot to be reclassified as a lot for the Land-for-the-Landless Program of the City of Manila.

SEC. 2. The subject road lot sought to be reclassified under this Ordinance shall be used as residential lot to form part of the City Government's Urban Housing Program to be awarded through sale and on installment basis to the actual *bona fide* tenants thereat.


SEC. 3. The City Tenants Security Committee through the City Urban Settlements Office shall oversee the implementation of this Ordinance.


SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval.


