

ORDINANCE NO. 8252

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 7999, BY MODIFYING THE LAND AREA OF TRANSFER CERTIFICATE OF TITLE NO. 57934 FROM 100.60 SQUARE METERS TO 232.10 SQUARE METERS
