

AN ORDINANCE ALLOTING THE AMOUNT OF TWENTY MILLION PESOS (PHP 20,000,000.00) TO BE TAKEN YEARLY FROM THE ACCOUNT OF THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY IN THE ANNUAL EXECUTIVE BUDGET FOR SEVEN CONSECUTIVE YEARS, SPECIFICALLY FOR THE PURPOSE OF EXPROPRIATING THE TAMBUNTING ESTATE LOCATED AT STA. CRUZ, IN THE THIRD DISTRICT, AS PROVIDED FOR IN CITY ORDINANCE NO. 7911, ENACTED BY THE CITY COUNCIL ON 19 SEPTEMBER 1996 AND APPROVED BY HIS HONOR, THE MAYOR, ON 14 OCTOBER 1996

Be it ordained by the City Council of Manila, in session, assembled, THAT:


**SECTION 1.** The amount of Twenty Million Pesos (PhP 20,000,000.00) shall be taken yearly from the account of the Land-for-the-Landless Program of the City in the Annual Executive Budget for seven (7) consecutive years is hereby allotted specifically for the purpose of expropriating the Tambunting Estate located at Sta. Cruz, in the 3<sup>rd</sup> District of Manila, as provided for in City Ordinance No. 7911, enacted by the City Council on 19 September 1996 and approved by His Honor, the Mayor, on 14 October 1996.


**SEC. 2.** This Ordinance shall take effect upon its approval.
