

AN ORDINANCE WITHDRAWING FROM PUBLIC USE THAT CERTAIN PARCEL OF LAND OWNED BY THE CITY OF MANILA WITH AN AREA OF ONE HUNDRED SIXTEEN SQUARE METERS AND FIFTY-FIVE SQUARE DECIMETERS (116.55 SQ. M.) MORE OR LESS, SITUATED AT PERLITA STREET, SAN ANDRES BUKID, IN BARANGAY 803, ZONE 87 IN THE FIFTH DISTRICT, AUTHORIZING ITS DISPOSITION TO ACTUAL BONA FIDE TENANT/S THEREAT, UNDER THE CITY'S LAND-FOR-THE-LANDLESS PROGRAM

Be it ordained by the City Council of Manila, in session, assembled, THAT:

**SECTION 1.** That certain parcel of land owned by the City of Manila measuring One Hundred Sixteen Square Meters and Fifty-Five Square Decimeters (116.55 Sq. M.) more or less, situated at Perlita Street, San Andres Bukid, in Barangay 803, Zone 87 in the Fifth District, is hereby withdrawn from public use and its disposition through sale on installment basis to the actual bona fide tenant/s thereat under the City's Land-for-the-Landless Program is hereby authorized.


**SEC. 2.** The City Tenants Security Committee through the City Urban Settlements Office shall oversee the effective implementation of this Ordinance.


**SEC. 3. Effectivity Clause.** - This Ordinance shall take effect upon its approval.
