

AN ORDINANCE EXPROPRIATING A CERTAIN PORTION OF A PARCEL OF LAND, SITUATED AT ESTERO DE CONCORDIA, PEÑAFRANCIA AND ZAMORA STREETS IN PACO, FIFTH DISTRICT OF MANILA, OWNED BY SPOUSES CARLITO AND LIGAYA OSTANI, REGISTERED UNDER TRANSFER CERTIFICATE OF TITLE NO. 213633, MEASURING APPROXIMATELY 3 METERS BY 12 METERS, TO BE UTILIZED AS RIGHT-OF-WAY BY RESIDENTS OF BARANGAY 827, ZONE 89, DISTRICT V, APPROPRIATING FUNDS THEREFOR

Be it ordained by the City Council of Manila, in session, assembled, THAT:

SECTION 1. The expropriation of a certain portion of a parcel of land situated at Estero de Concordia, Peñafrancia and Zamora Streets in Paco, Fifth District of Manila, owned by spouses Carlito and Ligaya Ostani, registered under TCT No. 213633 is hereby authorized.

SEC. 2. Appropriation Clause. - The amount of Seven Hundred Twenty Thousand Pesos (PhP 720,000.00) or so much thereof, as maybe necessary, is hereby appropriated out of any funds existing in the City Treasury to be made available for the implementation of this Ordinance.


SEC. 3. The *aforecited* parcel of land, when acquired, shall be solely and exclusively used as right-of-way by residents of Barangay 827, Zone 89 and nearby barangays.


Sec. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval.
