**ORDINANCE NO. 8266**

**AN ORDINANCE REGULATING THE USE OF A PORTION OF ESTERO DE SAN LAZARO, STA. CRUZ, MANILA IMMEDIATELY ABUTTING BARANGAY 225, DISTRICT II, BY PROVIDING FOR THE INSTALLATION OF STEEL GATES TO BE CLOSED EXCLUSIVELY FROM ELEVEN O' CLOCK IN THE EVENING (11:00 P.M.) TO FOUR O' CLOCK THE FOLLOWING MORNING (4:00 A.M.) AND FOR OTHER PURPOSES**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. DECLARATION OF POLICY.** – It shall be declared the policy of the City of Manila to secure and protect its inhabitants from lawless elements and other incidents that may endanger the lives and limbs of the residents.

**SEC. 2.** Pursuant to this policy there shall hereby be installed steel gates along a portion of Estero de San Lazaro, Sta. Cruz, Manila immediately abutting Barangay 225, District II, to be closed exclusively between the hours of eleven o' clock in the evening (11:00 p.m.) and four o' clock the following morning (4:00 a.m.); *PROVIDED, That* beyond such time or in an event of an emergency, said steel gates shall be open for use by the public.


**SEC. 3. IMPLEMENTING GUIDELINES.** – For the implementation of Section 2 hereof, the following shall be observed:

1. A conspicuous and visible notice, placard or marking shall be installed near or at the steel gates to sufficiently apprise the public of the limitations concerning the use thereof;
2. Such steel gates must be immediately opened by the barangay officials concerned without unnecessary delay outside of the hours provided for under Section 2, hereof, or in case of an emergency;
3. The steel gates shall be manned at all times by a responsible barangay official who shall ensure that Section 2 hereof, is strictly implemented; and
4. The steel gates shall be painted legibly with the following, and clearly state and read as follows: "CLOSED TO PASSERS-BY BETWEEN ELEVEN O' CLOCK IN THE EVENING (11:00 P.M.) TO FOUR O' CLOCK THE FOLLOWING MORNING (4:00 A.M.)".


**SEC. 4. EFFECTIVITY CLAUSE.** – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on February 21, 2012.


