PREAMBLE

WHEREAS, there is a recently vacated position indicated as PEST CONTROL OFFICER under Item No. 26 then held by Maria Luisa Belmes who was promoted to the position of Health Education and Promotion Officer I in the Manila Health Department;

WHEREAS, in the Personnel Schedule in the Office of the Insect Vermin Control, there is one position of Pest Control Officer which was created to provide for an Officer in the Pest Control Group in the said department;

WHEREAS, unfortunately, the position of Pest Control Officer is not listed in the Civil Service Commission Qualification Standards of 1991, hence, there is the need for the position to be appropriately changed to PEST CONTROL TECHNICIAN: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The Position Title of Pest Control Officer of Item No. 26 in the Staffing and Compensation Profile and Personnel Schedule (Book II) of the Manila Health Department of Ordinance No. 8262, otherwise known as the 2012 Executive Budget is hereby amended, to read as follows:

"26 Pest Control Technician x-x-x x-x-x x-x-x x-x-x x-x-x"

SEC. 2. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 8, 2012.
