ORDINANCE NO. 8269

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE ACQUISITION EITHER BY NEGOTIATION, EXPROPRIATION OR BY ANY OTHER LEGAL MEANS OF THAT CERTAIN PARCEL OF LAND CONSISTING OF AN AREA OF SIXTY SQUARE METERS AND TWENTY SQUARE DECIMETERS (60.20 SQ. M.), MORE OR LESS, LOCATED IN BARANGAY 775, ZONE 84, SAN ANDRES BUKID, MANILA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 175988 IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA, AND REGISTERED UNDER THE NAME OF ADORACION B. BOLANGAITA, FOR PURPOSES OF CONSTRUCTING THE MULTI-PURPOSE HALL OF BARANGAY 775, ZONE 84

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. TITLE. – The acquisition either by negotiation, expropriation or by any other legal means of that certain parcel of land consisting of an area of Sixty Square Meters and Twenty Square Decimeters (60.20 Sq. M.), more or less, located in Barangay 775, Zone 84, San Andres Bukid, Manila, covered by Transfer Certificate of Title No. 175988 in the Registry of Deeds for the City of Manila, and registered under the name of Adoracion B. Bolangaita, for purposes of constructing the Multi-Purpose Hall of Barangay 775, Zone 84, is hereby authorized.


SEC. 2. The City Mayor is hereby authorized to utilize any available funds in the City Treasury or from the other funding facilities from other government agencies for this purpose.

SEC. 3. The aforementioned parcel of land, when acquired, shall be utilized for purposes of constructing a Multi-Purpose Barangay Hall of Barangay 775, Zone 84, San Andres Bukid, Manila.


SEC. 4. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 8, 2012.


