ORDINANCE NO. 8272

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLES TERMINAL), AS AMENDED, BY INCLUDING THEREIN THE ADDITIONAL LOADING AND UNLOADING AREAS OF THE RIZAL AVENUE, SAN LAZARO, OROQUIETA, QUIRICADA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*

SECTION 1. Section 2.a (Tricycles Terminal) of the City Ordinance No. 7755, is hereby furthermore amended by including therein the Loading and Unloading Areas of the RIZAL AVENUE, SAN LAZARO, OROQUIETA, QUIRICADA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (RILAORQUITODA) by adding another number, to read as follows,

“RIZAL AVENUE, SAN LAZARO, OROQUIETA, QUIRICADA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (RILAORQUITODA)

Loading and Unloading Area

a. SAN LAZARO STREET SANTA CRUZ, MANILA”

SEC. 2. Sec. 2 of Ordinance No. 7871, as amended, is hereby further amended by adding another number to read as follows.

“ASSOCIATION	ROUTE	R.M.C.
Rizal Avenue, San Lazaro, Oroquieta, Quiricada Tricycle Operators and Driver’s Association, Incorporated (RILAORQUITODA)	Rizal Avenue, San Lazaro St. Santa Cruz, Manila	30 units

Authorized Route Line: Bambang St., Saturnino Herrera, Oroquieta St., P. Guevarra St., Sulu St., Felix Huertas St., Alvarez St., Quiricada St., Maria Clara St., Makata St., Tomas Mapua St., SM San Lazaro.”

SEC. 3. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon its approval.
