ORDINANCE NO. 8279

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755, (UNDER TRICYCLES TERMINAL), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF THE PASANG MASDA CONSUELO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION IN CONSUELO STREET CORNER LACSON STREET AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycles Terminal) of Ordinance No. 7755 is hereby furthermore amended by adding another number, to read as follows:

AND DRIVERS ASSOCIATION
(PASANG MASDA CONTODA)**

Loading and Unloading Area

- a. SM City San Lazaro Tricycle Bay located at Consuelo Street, corner Lacson Street."

SEC. 2. Sec. 2 of Ordinance No. 7871, as amended, is hereby further amended by adding another number to read as follows:

SEC. 3. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.




