

ORDINANCE NO. 8279

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.8 OF ORDINANCE NO. 7755, (UNDER TRICYCLES TERMINAL), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF THE PASANG MASDA CONSUELO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION IN CONSUELO STREET CORNER LACSON STREET AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycles Terminal) of Ordinance No. 7755 is hereby furthermore amended by adding another number, to read as follows:

"PASANG MASDA CONSUELO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (PASANG MASDA CONTODA)

Loading and Unloading Area

 SM City San Lazaro Tricycle Bay located at Consuelo Street, corner Lacson Street."

SEC. 2. Sec. 2 of Ordinance No. 7871, as amended, is hereby further amended by adding another number to read as follows:

Maceda St., Basilio St., Instruccion St., Sisa St., Ibarra St., Crisostomo St., Casañas St., Musa St., Josefina St., Main Road: Blumentritt St., Makiling St., Calamba St., Maceda St., Simoun St., Laong-Laan St., Dapitan St., P. Margal St., P. Florentino St., VICE VERSA".
