ORDINANCE NO. 8276

AN ORDINANCE IMPLEMENTING A STANDARD THREE-METER EASEMENT ALONG THE TRIBUTARIES OF THE PASIG RIVER SYSTEM IN THE CITY OF MANILA, INCLUDING ESTEROS, CREEKS AND OTHER SIMILAR WATERWAYS, IN STRICT COMPLIANCE WITH THE PROVISIONS OF ARTICLE 51 OF PRESIDENTIAL DECREE NO. 1067 (THE PHILIPPINE WATER CODE) AND ARTICLE 638 (LEGAL EASEMENT) OF THE CIVIL CODE OF THE PHILIPPINES


Be it ordained by the City Council of Manila, in session assembled, **THAT:**

**SECTION 1.** There is hereby implemented a uniform three-meter easement along the tributaries of the Pasig River System in the City of Manila, including esteros, creeks and other similar waterways, in strict compliance with the provisions of Article 51 of Presidential Decree No. 1067 (The Philippine Water Code) and Article 638 (Legal Easement) of the Civil Code of the Philippines.


**SEC. 2.** This Ordinance shall take effect upon its approval.


