ORDINANCE NO. 8277

AN ORDINANCE FURTHERMORE AMENDING SECTION 2a OF ORDINANCE NO. 7755 (UNDER TRICYCLES TERMINAL), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF ORO B, ZOBEL, SAN ANDRES, STA. ANA, TEJERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INCORPORATED (OZSSATTODA) AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN THE ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT

SECTION 1. Section 2a (Tricycles Terminal) of Ordinance No 7755 is hereby furthermore amended by including therein the Loading and Unloading Area of the Oro B, Zobel, San Andres, Sta. Ana, Tejeron Tricycle Operators and Drivers Association, Inc. (OZSSATTODA) by adding another number, to read as follows:

"ORO B, ZOBEL, SAN ANDRES, STA. ANA, TEJERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, INC. (OZSSATTODA)

Loading and Unloading Area

a. Oro B Street near the corner of Zobel Roxas Street."

SEC. 2. Section 2 of Ordinance No. 7871 is hereby further amended by adding another number to read as follows.

Roxas St. - Onyx St. - Liwayway St. - Pasig Line St. - Arellano St. - Elioraga St. - Granate St. - Crisolita St. - Topacio St. - Zapiro St. - Rubi St. - Nakar St. - Coral St. - Esmeralda St. - Amatista St. - Opalo St. - Estrada St. - Dagonoy St."

SEC. 3. Effectivity Clause - This Ordinance shall take effect upon its approval
