Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Subparagraph b), Paragraph 13, Section 2a. of Ordinance No. 7755, as further amended by Ordinance No. 7928 is hereby furthermore amended by extending the route of the Camarines Tricycle Operators and Drivers Association Incorporated from Camarines Street corner Rizal Avenue up to Felix Huertas Street to read as follows:


"27. Camarines Tricycle Operators and Drivers Association, (CAMARINES-TODA), INC.

a. A.S. Herrera Street (formerly Camarines Street) corner Rizal Avenue - to Felix Huertas Street"


SEC. 2. This Ordinance shall take effect upon its approval.


