ORDINANCE NO. 8279

AN ORDINANCE APPROVING THE PAYMENT OF TEN MILLION TWO HUNDRED EIGHTY FIVE THOUSAND TWO HUNDRED NINETY- THREE PESOS AND THIRTY-EIGHT CENTAVOS (PHP 10,285,293.38) AS JUST COMPENSATION IN FAVOR OF THE HEIRS OF THE LATE JUSTICE JOSE B.L. REYES FOR THE PIECES OF PROPERTY BEING UTILIZED BY THE CITY OF MANILA AS CITY STREETS FOR PUBLIC USE AND AUTHORIZING THE CHIEF EXECUTIVE TO RELEASE THE FUNDS ALLOCATED FOR THAT PURPOSE

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The payment of just compensation of Ten Million Two Hundred Eighty Five Thousand Two Hundred Ninety-Three Pesos and Thirty-Eight Centavos (PhP 10,285,293.38) in favor of the heirs of the Late Justice Jose B.L. Reyes for the pieces of property being utilized by the City of Manila as City streets for public use is hereby approved.

- SEC. 2. The City Executive is hereby authorized to release whatever funds that are allocated for that purpose which may be certified as available by the City Treasurer and the City Accountant, subject to the usual auditing and accounting procedures as prescribed by the Commission on Audit
 - SEC. 3. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 28, 2012.
